**HANOVER TOWNSHIP, SPRINT 2 SPRING 5K, ASSUMPTION OF RISK, WAIVER, AND
RELEASE FROM LIABILITY**

FOR PERSONS UNDER EIGHTEEN (18) YEARS OF AGE, A PARENT OR LEGAL GUARDIAN MUST COMPLETE AND SIGN THIS FORM. PLEASE READ CAREFULLY BEFORE SIGNING THIS ASSUMPTION OF RISK, WAIVER, AND RELEASE FROM LIABILITY: In consideration for my (my child's) opportunity to participate in the Hanover Township "Sprint 2 Spring 5k" ("the Race"), I voluntarily agree to the following terms for myself (my child):

1. ASSUMPTION OF THE RISK. I assume all risks which are foreseeable and involved with or may arise out of my (my child's) voluntary participation in the Race, including, but not limited to, the negligent and/or willful and wanton acts of others, the criminal and or intentional acts of others, the omission of an act of another, a defect or condition of the road, a defect in the vehicles used for transport, a defect in the equipment used in the Race, the unavailability of emergency care, terrorist activity, war, and/or natural disasters.

2. RELEASE. I release Hanover Township, the City of Elgin, all sponsors of the Hanover Township Sprint 2 Spring 5k Race, and all of their officers, trustees, employees, volunteers, and agents from and against any and all claims, causes of action, injuries, illnesses, damages, and/or cost of expenses arising out of or related to the Race, including, but not limited to, the risks involved in running a road race, including those claims, causes of action, injuries, illnesses, damages, and/or cost of expenses based on death, bodily injury, or property damage whether or not caused by the negligence or other fault of the parties being released.

WAIVER. I hereby waive, for myself (my child), the protection afforded by any statute or law in any jurisdiction whose purpose, substance, cause and/ or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing this release. This means, in part, that I am releasing unknown future claims for myself (my child).

PARTICIPATION. I certify that I (my child) am medically able to perform this event, I (my child) am in good health, and I (my child) am properly trained to participate in the Race. I agree to abide by any decision of a Race official relative to any aspect of my (my child's) participation in the Race, including the right of any Race official to deny or suspend me (my child) from participation in the race for any reason whatsoever.

RULES OF THE RACE. I (my child) attest that I have read the Rules of the Race and agree to abide by them. I understand that bicycles, skateboards, baby joggers, roller skates, roller blades, animals, and personal music players are not allowed in the Race.

INDEMNIFY AND DEFEND. I agree to indemnify and defend Hanover Township, the City of Elgin, all sponsors of the Hanover Township Sprint to Spring 5K, and all of their officers, trustees, employees, volunteers, and agents against, and hold them harmless from, any and all claims, causes of action, damages to or destruction of any property of the indemnitee or any others, injury or death that may result to me (my child), or anyone else while participating in the Race.

REPRESENTATIVES. I understand that I am entering into this agreement for myself, my heirs, assigns and legal representatives. I understand that where "my child" is used in this Assumption of Risk, Waiver, and Release from Liability, I am agreeing to the terms of this Agreement on behalf of my child. **PHOTOGRAPHIC RELEASE.** I hereby grant permission for Hanover Township and the City of Elgin to use, reproduce, and publish photographs, motion picture, and electronic recordings taken of me (my child) while participating in the Race.

SEVERABILITY. If any provision of this Agreement is prohibited, invalidated, or unenforceable in any jurisdiction, that provision will, as to that jurisdiction, be ineffective to the extent of the prohibition, invalidity or unenforceability without invalidating the remaining provisions of this Agreement or affecting the validity or enforceability of that provision in any other jurisdiction, unless it materially alters the nature or material terms of this Agreement.

ACKNOWLEDGMENT. I HAVE READ AND UNDERSTAND THIS AGREEMENT AND REALIZE IT RELATES TO SURRENDERING AND RELEASING VALUABLE LEGAL RIGHTS AND DO SO FREELY AND VOLUNTARILY. MOREOVER, I UNDERSTAND THAT MY (MY CHILD'S) PARTICIPATION IN THE RACE IS VOLUNTARY.
